CE Requirements and CPR Renewals

The Mississippi Continuing Education requirements are 20 hours annually. A minimum of 10 hours must be TPA (therapeutic); 1 hour minimum each in DEA and CPR (both current at the time of renewal). A minimum of 6 hours is required if PEP certified. If you were enrolled in Optometry school any time during the current calendar year, you are exempt from the continuing education requirements.

OE TRACKER

The Board encourages all renewing optometrists to utilize OE TRACKER to report CE hours during renewal. OE TRACKER can save you time and reduce your paperwork by tracking all your CE credits electronically.
