Call to Order

IV. YAG Capsulotomy Re-Test

1. After discussion and a review of Counsel's recommendation, Dr. Blackmer moved, with a second by Dr. Eckard to notify the PEP applicants who tested on July 12, 2025, that due to equipment failure which interfered with MSBO's ability to "perform the YAG Capsulotomy procedure using an acceptable and effective pattern," they would be required to perform this required procedure with an approved preceptor at the time of completion of the eight (8) hour required preceptor training. A letter will be sent to all approved preceptors

- requesting that they notify Cynthia Brown at MSBO to obtain the "eye" and required completion notification. The slit lamp set-up attachment may also be available for their use, if required. Yvonne Laird was authorized to sign the letters on behalf of the Board. The vote was unanimous. Motion carried.
- 2. Dr. Blackmer moved, with a second by Dr. Parrish to revise the Mississippi Board Test Grading Rubric YAG Capsulotomy to remove "If no, automatic FAIL." The revised rubric would read going forward, "Perform the procedure using an acceptable and effective pattern. (2 points)". The vote was unanimous. Motion carried.
