MINUTES

AS AMENDED, APRIL 11, 2026

In accordance with MCA § 25-41-11

I. Call to Order

The Mississippi State Board of Optometry special called teleconference meeting was called to order by Board President, Kimberly Ragan, O.D. at 6:00 PM on Thursday, February 17, 2026.

II. Roll Call

III. Approval of the Agenda

Dr. Parrish moved, with a second by Dr. Middleton to approve the agenda with the following addition: VII. Triple Light Therapy. The vote was unanimous. Motion carried.

IV. EXECUTIVE SESSION

Dr Parrish moved to go into closed session to determine whether as Executive Session is needed. The vote was unanimous. Motion carried.

Dr. Middleton moved, seconded by Dr. Blackmer, that the Board had reason under Miss. Code Ann. §25-41-7 (4)(b) and (d), as amended, to go into Executive Session namely investigative proceedings regarding allegations of misconduct or violations of law with respect to prospective litigation or issuance of an appealable order when an open meeting would have a detrimental effect on the litigating position of the Board. The vote was unanimous. Motion carried.

Dr. Middleton moved, with a second by Dr. Blackmer to come out of Executive Session. The vote was unanimous. Motion carried.

RETURN TO REGULAR SESSION

Yvonne Laird, Executive Director, reported in Open Meeting action taken during Executive Session, as follows:

Upon recommendation by the Board Investigator, Dr. Eckard, Dr. Parrish moved, with a second by Dr. Blackmer to dismiss this case as no violations of law or rules were found. The vote was, as follows:

V. YAG Licensure by Endorsement
Tabled until the April 11, 2026, meeting.

VI. Direct Selective Laser Trabeculoplasty (DSLT)

Dr. Eckard moved, with a second by Dr. Blackmer to call for a vote regarding whether or not DSLT is an intraocular surgical procedure as set forth in Miss. Code Ann. § 73-19-1(3). The vote was, as follows:

Dr. Blackmer – not intraocular
Dr. Eckard – not intraocular
Dr. Middleton – intraocular
Dr. Parrish – not intraocular
Dr. Ragan – intraocular

The Board moved, with a vote of three (3) to two (2) that DSLT is not an intraocular surgical procedure as contemplated in Miss. Code Ann. § 73-19-1 (3) and, therefore, by definition, is not otherwise excluded from the practice of optometry.


The motion was made by Dr. Middleton with a second by Dr. Parrish that in accordance with Rule 1.1.(h) [current] and Rule 1.1.A.8 [effective February 28, 2026] only those PEP (Primary Eye Care Procedures Optometrist) certified can perform laser procedures. The vote was unanimous. Motion carried.

Dr. Eckard asked to discuss Triple Light Therapy at this time. It was recommended that Dr. Eckard provide additional information relative to this advanced technology treatment for review prior to the release of the April 11, 2026, meeting agenda.

VII. Dr. Eckard moved, with a second by Dr. Blackmer that the meeting be adjourned at 7:35 PM. The vote was unanimous. Motion carried.
